**Public call for nomination of the State Quality Council members at the
Kosovo Accreditation Agency**

The Ministry of Education and Science of the Republic of Kosovo, based on the Law on Higher Education no. 04/ L-037 for the Law on Kosova Accreditation Agency no. 08/L-110, announces public call for nomination of three (3) members of the State Quality Council (SQC) at the Kosovo Accreditation Agency.

All legal entities registered in Kosovo and natural persons, citizens of the Republic of Kosovo, have the right to nominate or self-nominate as members of the SQC.

1. Nomination fields

MES seeks nominations for these fields:

- Medical Sciences – one (1) member;
- Humane Sciences – one (1) member;
- One (1) member from among the students.

The mandate of SQC members is (4) years, with exception of the student member mandate, which is (2) years.

2. Criteria for candidates

Candidates for members of the SQC must meet the following criteria:

- 2.1. Be citizens of the Republic of Kosovo;
- 2.2. Candidates from the academic staff must have the degree of "Doctor of Science", internationally recognized research experience, relevant academic experience of at least five (5) years, as well as experience in the field of quality assurance in higher education;
- 2.3. Knowledge of English is preferable.;

- 2.4. Në In case the local members are graduates outside Kosovo, to have a diploma recognition at the National Center for Recognition, Equivalence and Academic Information ENIC-NARIC;
- 2.5. Have considerable knowledge about the functioning of higher education and quality assurance in Kosova which is evidenced through engagement or participation in relevant activities, projects, positions;
- 2.6. To have considerable knowledge and experience for the functioning of the European Higher Education Area and international quality assurance standards;
- 2.7. The student candidate must be at least at the level of master's or doctoral studies at Kosovo HEIs and have knowledge of the English language.

The right to nominate

Each legal entity may nominate up to six (6) candidates for the SQC, while natural persons may self-nominate..

Documentation required for nomination

The documentation must contain:

1. Nomination (application) form, completed and signed by the candidate;
2. Attached to the form:
 - a) In case of nomination by the institution – Declaration no. 2;
 - b) In case of self-nomination – Declaration no. 1;
3. Copy of identification document of the candidate;
4. CV signed by the candidate, proving fulfillment of the criteria according to the legislation in force and this call;
5. Notarized copies of university diplomas (Bachelor, Master and Doctorate);
6. For student candidates: academic and professional evidence (notarized copies of diplomas), as well as official confirmation of current student status;
7. Evidence of relevant academic experience;
8. If studies were completed abroad: copy of the decision/decisions for recognition from the Ministry of Education and Science of the Republic of Kosovo;
9. Certificate on criminal record, issued by the Kosovo Judicial Council, which proves that the candidate has no criminal convictions in the central records (an online certificate from the e-Kosova platform is also accepted).

Remark: Submitted documents will not be returned.

A person who: cannot be elected as a member of the SQC:

1. Has held a political position in Kosovo for the last three (3) years;
2. Has been founder, co-founder, shareholder or board member in a HEIs during the last five years;

3. Has current engagement in more than one higher education institution, inside or outside Kosovo;
4. Has been convicted by a final decision for a criminal offense punishable by imprisonment for over six (6) months, according to the Criminal Code of the Republic of Kosovo;
5. There is a conflict of interest, according to the legislation in force.

Important information for the parties:

Candidates who are selected and ratified may begin exercising their duties only after completing all procedures according to the legislation in force, taking into account the end of the mandate of the current members of the SQC, according to the established deadlines.

The deadline for nominations is eight (8) calendar days from the date of the public call announcement on the MES website, respectively until 15.04.2026.
